Dear Senator Glenn;

The airborne object depicted on the enclosed photograph was recorded by a Clermont County, Ohio resident on a home video camera on November 10, 1994. The resident claims to have been distressed by the 2:00 A.M. overflight of the silent, unknown object, which parades its presence by a very noticeable assemblage of four white lights in a triangular configuration.

The videotape has been exhaustively analyzed by Associates for Scientific Knowledge computer specialists for months, and no determinate identification can be applied to the object recorded on the November 10 videotape. Computer enhancement and enlargement of the recording has revealed an unequivocal triangular surface behind the headlight arrangement. The surface is illuminated by the four very bright lights, and curiously resembles the hull of the B-2 STEALTH BOMBER.

The soundless device clearly demonstrates a 'rolling' motion, as seen on the videotape, appearing to complete a maneuver that would put a conventional aircraft in an 'upside-down' pitch at the conclusion of the roll. This feat, if performed by conventional aircraft (military or otherwise) is a highly dangerous maneuver over a populated region that would obviously put the lives of the area residents in jeopardy due to the risk of an accident.

In addition to the camera operator that has recorded the material, several other residents in the immediate vicinity have also stepped forward with declared statements claiming to have seen this and other unknown aerial objects in the exact same region, some multiple sightings from independent witnesses, and others taking place days or weeks after the initial event.

Curiously, the object depicted on the November 10 video is strangely similar in appearance to photographs made of an object during highly publicized events in the winter of 1989 and 1990 in the skies over Belgium and Germany, which was detected on radar and pursued by military aircraft. Comparable also in its appearance are the many objects seen in The Hudson River Valley area of New York, in which one observer declared that he 'jogged along with it, and could reach up and touch it.'

The journal AVIATION WEEK & SPACE TECHNOLOGY has contended that many observations of triangular shaped craft is traceable to secret flight testing of the NORTHROP TR-3A, a classified

tactical reconnaissance vehicle about 42 ft. long with a 60 to 65 ft. wingspan. This explanation is weak, however, due to the frequently reported 'high performance maneuvers' described by some well-qualified witnesses (for example: 90° turns on its wingtip, racetrack turns at high speed, tremendous acceleration from a dead stop to incredible speeds, rotating in place and hovering vertically). Speculation has also centered around the top secret AURORA Air Force reconnaissance and DARKSTAR military surveillance programs, but questions continue to emerge when one considers why military testing or operational aircraft would parade itself with bright headlights around populated regions, alarming residents and demonstrating its high performance capabilities, mostly during the late-night early morning time periods between 12:00 A.M. to 4:00 A.M.

When asked to comment on the triangular-shaped vehicles seen by multiple observers the December 1, 1991 POPULAR MECHANICS magazine quotes Pentagon Public Affairs Officer Captain Betsy Freeman as saying 'We have no aircraft matching these descriptions.'

Inquiries are being placed with your office regarding these matters in hopes that the factual data could be given and subsequent investigations could be made with appropriate, high-level authorities so that answers could be forthcoming.

A tremendous amount of concern has been expressed by the many alarmed observers who have reported these and other unknown aircrafts. Without comments or open investigations by any agency of the Federal Government into these ongoing matters, conspiracy and exotic theories abound from the informed public, and they are understandably troubled at the thought of secret military testing in their neighborhoods and communities that could possibly subject them to covert aerial surveillance from secretive federal aircraft or having their lives placed in jeopardy from accident risk due to this activity.

Please assist us in obtaining much needed answers to these current and very serious questions.

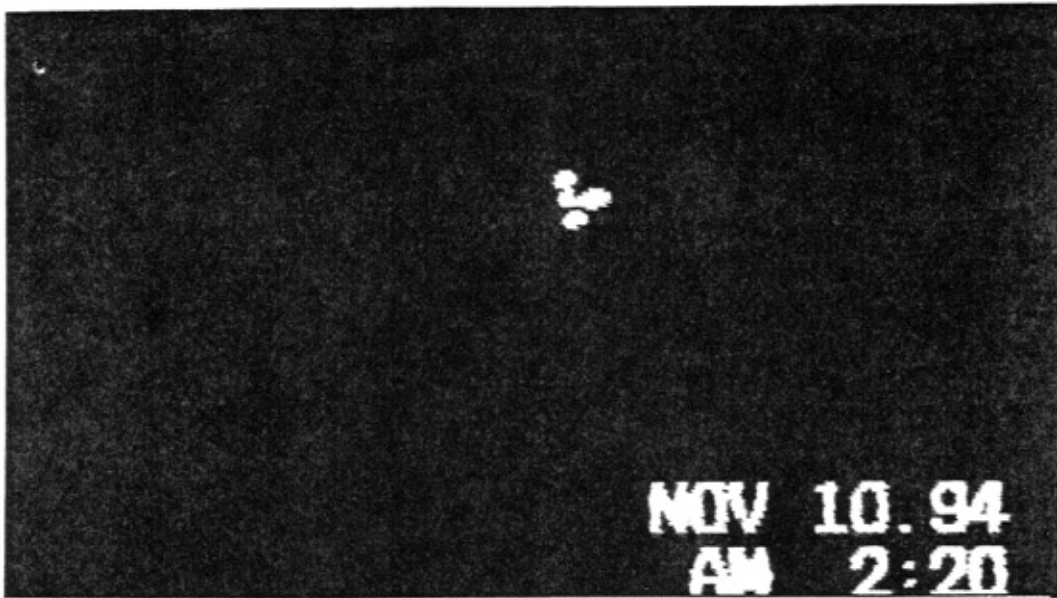

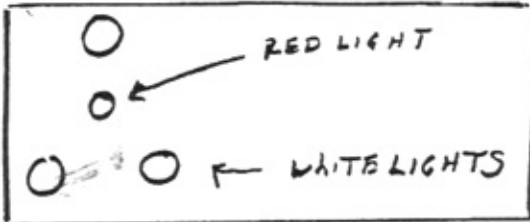

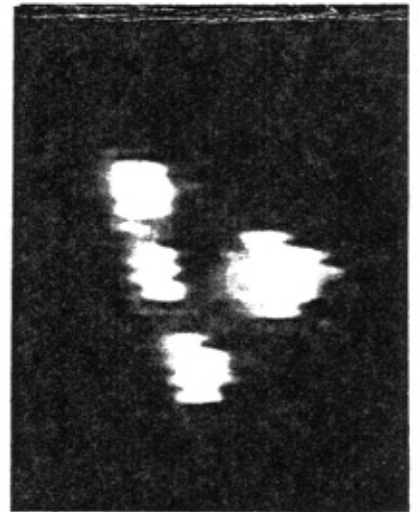


BELOW: Enhanced still from the Owensville recording, clearly illustrating a solid, triangular-shaped surface situated behind the headlight arrangement.

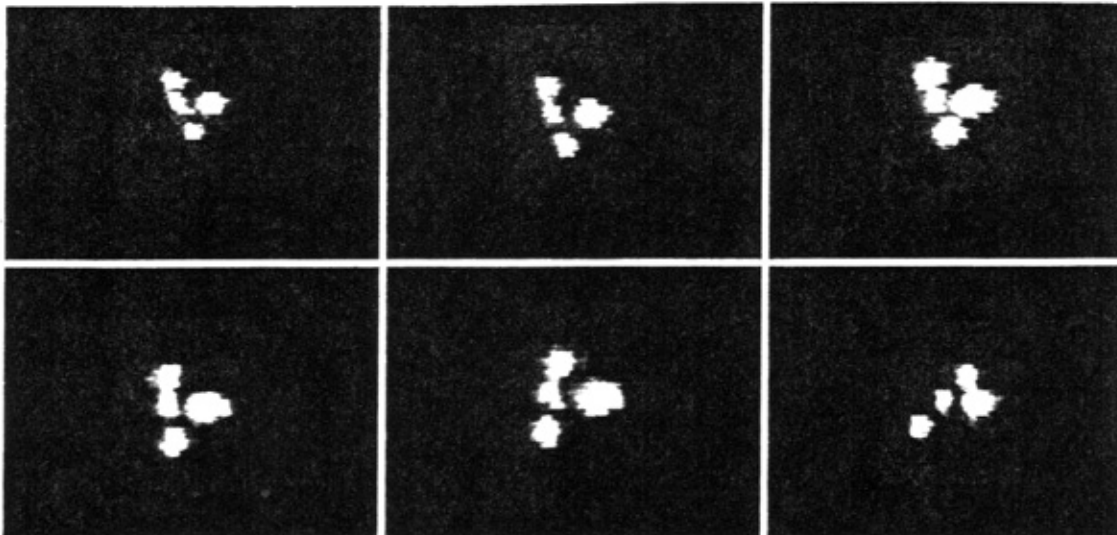


TOP: Still image from the Owensville recording
