## Finally.... Richard C. Doty's United States Air Force Service Records ( Well, Nearly... )

The UFO controversy contains a handful of individuals who need no introduction. One such figure is Richard C. Doty. Formally with the United States Air Force (USAF), Doty has become somewhat legendary. To some, he is an officially sanctioned disinformation agent. To others, he is the quintessential truth twisting hoaxer. To many, he is an odd combination of these two extremes. I am not going to give yet another synopsis of Doty's unusual contribution to UFO history. Others have already done so, and they have done it quite well. There are three books that immediately come to mind when pondering the Doty saga. They are, Christian Lambricht's "*X-Descending*", Greg Bishop's "*Project Beta: The Story of Paul Bennewitz, National Security, and the Creation of a Modern UFO Myth*", and Mark Pilkington's "*Mirage Men: A Journey into Disinformation, Paranoia and UFOs*". Further, MJ Banias's upcoming treatment of UFO subculture will also contain an important Doty discussion.

Over the years, many a researcher has attempted to clarify exactly what Richard Doty did with the USAF, and when, and where. A near total lack of Doty's USAF service records has presented significant barriers to further investigation, and the few items which have been legally released in recent years are very brief indeed. Just once, though, a dogged investigator got quite lucky.


Sometime in late 1987, or early 1988, UFO researcher Larry Bryant submitted a Freedom of Information (FOI) request to the Office of the Secretary of the Air Force (OSAF) for copies of Richard Doty's USAF service records. Soon after, Special Agent Cecil W. Fry, the Chief of Information Release at Air Force Office of Special Investigations (AFOSI) Headquarters, Washington DC, made the decision to withhold all existing records related to Doty. On the 21st of February, 1988, Bryant wrote back to the OSAF appealing AFOSI's verdict. On the 31st of October, 1988, Mr. Steven A. Thompson, who was with the OSAF's Office of Administration, replied to Bryant's appeal letter, and, thankfully, enclosed a number of records, albeit with redactions. While all this was going on, Bryant was also corresponding with Kirtland Air Force Base in New Mexico. On the 8th of September, 1988, Bryant submitted an FOI request to Kirtland asking for any service paperwork they held on Doty. It is unknown who initially handled his request, but two weeks later it was forwarded to the 1606th Air Base Wing. On the 27th of September, 1988, Mr. A. Albert Sanchez, who was the FOI Manager at the 1606th ABW, released a significant number of records to Bryant. Put together, the OSAF and the 1606th ABW released some twenty-five pages of Doty's service files.

We don't know how many more pages may exist. Even the USAF may not have a central Doty service file. Further, some of the documents, as I have mentioned, are redacted. Whatever the situation, the records Larry Bryant *did* manage to obtain have, to my knowledge, seldom seen the light of day. I do not intend to analyse this material. Other researchers can do that, and no doubt some will. So, with that, Doty's service file, or at least some of it, is imaged below.



- Before you depart on leave, you should complete DD Form 228, Temporary Mail Disposition Instructions, at the Postal Service Center, to direct your mail during your leave.
- If you take more leave than you will accumulate before expiration of your term of service (ETS), the AFO will automatically collect all pay and allowances you receive during the period of excess leave. Advance notice which becomes excess leave at your ETS is collected the day before you enter into extension, or on your date of expiration, whichever occurs first, without regard to any extension or adjusted date of expiration (DOSA).
- Remember:
  - If your leave is non-cumulative on the date you include in your leave request as "first day of chargeable leave."
  - If you are on charge, your absence is projected future date before departing on leave you must notify the leave approving authority.
  - If you are not on charge, you must notify the leave approving authority.
  - If you are on charge, you must notify the leave approving authority.
  - If you are on charge, you must notify the leave approving authority.
- You must be in the field or on your permanent duty station before start and upon completion of leave. Local travel is defined as the place of residence or home from which the member commences to the duty station on a duty workday basis.
- Before departure, you must have an approved leave authorization (AF Form 288, Leave Request Authorization), or special order and enough funds for expenses, including costs for travel. Do not use more than your return on time by military air transportation.
- You must be available to be contacted through the address shown on your leave authorization. Members with key mobility deployment responsibilities must notify their unit mobility officer (MCO) or alternate of scheduled leave as soon as possible before departure.
- If you need an extension of leave, call or send a telegram to the individual who approved your leave. If you are an emergency leave, call the nearest American Red Cross chapter to notify the commanding emergency to the leave approving authority.
- If you require medical or dental treatment while on leave, go to the nearest unannounced emergency treatment facility. If you must be treated for an emergency at a civilian facility, charge the civilian source of care as a patient's claim for payment to the nearest Air Force medical treatment facility (Reserve Management Office). The claim must be itemized, including diagnosis, your pay grade, military address, and SSN.
  - If you are hospitalized in a military medical treatment facility, ensure that your organization of assignment is notified as soon as possible.
  - If you are hospitalized in a civilian facility, notify the nearest Air Force medical treatment facility (Patient Affairs Office) as soon as possible.
- If you are in need of funds, go to the nearest Air Force finance office and show your leave orders and current Leave and Earnings Statement (LES). Payment, if authorized, cannot exceed unpaid pay and allowances to date. If you do not have your LES, you may expect to delay.
- Observe all traffic rules if you travel by automobile.
- If you plan to travel by commercial air at reduced rates, contact the airline to learn what documents you need.

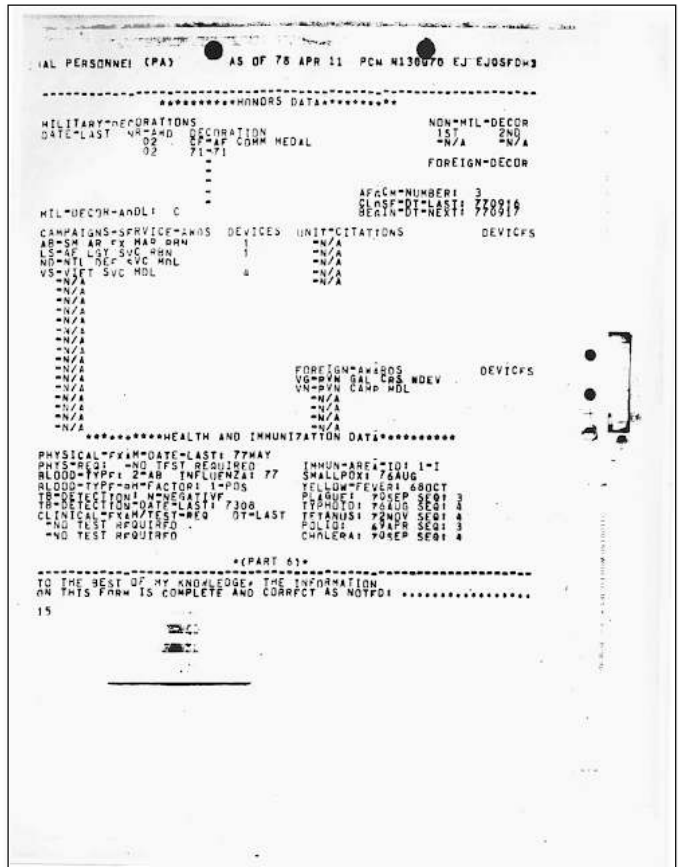
