**Evaluation of Photographs or Video Evidence:** After looking at the videos several time and slowing them down to analyze there is an object there and it dropped a smaller one as well.

**Witness Background:** The witness works at [REDACTED] in Boise and has for 9 years to date.

**Witness Interview:** I called the witness and introduced myself and the interview began. I asked him how far away from the house was the while driving home when he said this object and he stated about ½ mile or less. He said they only sat there for about 4-5 seconds and stated to his wife let's go home and get the camera. They got home he ran inside got the camera and when he came back out he said that he got it on camera just before the object dropped another object that was the same color and a little smaller. I said what you mean dropping another object and he said that as it came down it was moving slow but then it sped up and disappeared. I asked where did it disappear straight down or moving off to the side and he said straight down. My next question was for him to describe the object and the color size and direction of the object. He said the size was about the size of the quarter and it was very red as he put it, I mean almost like a maroon color but brighter or a deep red if you will. He said it was hovering that it moved a little bit to the east and then it dropped the second object and then moved a little more to the east sat there for about 2 or 3 minutes and disappeared. I asked him how long he saw the whole thing when they got home and he said maybe 5 minutes tops and it just disappeared and it was something I've never seen before it was kind of amazing to say the least.

I then asked about the distance from him and he said maybe a mile – mile and a half at about 30° maybe 40° and about 2000 2500 - feet in altitude. I asked about the weather if there any clouds and he said no it was very clear and crisp. I asked him how many witnesses there were an east of just himself and his wife and there was nobody else around that he saw that may have seen it or possibly looking that way. He stated at that time as well that he can really noticed a smaller craft or object coming down from a until you look at it on his computer and that's when he decided to go ahead and report it right away. He got a laughingly said that he always keeps his camera charged just in case this happens and I stated why I'm glad you did that is great. I asked about sound and he said there was none and he said that they were in the backyard vision for the east and it seemed like the object was over B a camel's back reserve and park. We talked in general for couple minutes and I asked him what he did for a living and he works at [REDACTED] in Boise and has been for nine years or on 10 but he and saving about where his wife works if she does that all.

If he stated the fact that this was similar to what his wife had seen a couple months back and that in their younger days both of them had seen other objects but never has reported or taking any photos or videos. He said I'd like to find out if we could figure out what this thing was and I stated I'm with you there. He started talking about other things and the interview had ended at this point.

#### Detailed Description of the UFO Event:

Driving home when my wife and I saw a red light in the sky. It caught my eye because I am always looking up for strange lights. I asked my wife what she thought and she recommended that we pull over so I did. When we pulled over I could tell that it wasn't moving because I judged it through my view through the trees. I told my wife that we should hurry home and grab the video camera and hopefully it would still be there. Got home ran inside grabbed my camera and got it into view just in time to see it drop another orb but this one was flashing. It was moving down slowly then stopped and almost seemed to come back up. Then the flashing object went back down and stopped for a second then shot down to the ground. I didn't realize the speed of the objects decent until watching the video back in slow motion. It was like a bullet and didn't make a sound. After the second object was out of view I zoomed in on the initial object and it flickered and blinked out.

**Witness Background:** The witness is and has been for a lot of years a Teacher at Mountain Home AFB in Mountain Home Idaho.

**Witness Interview:** Before the interview begins I had sent two emails to the witness because there was no phone number. I did receive an e-mail back stating that he would have to talk to his wife about it first and if there's anything that I might be able to send or ask via email. I responded to his e-mail on that and also included some questions for him to answer and this is on the 28<sup>th</sup> of December at about 2:25 PM. He responded by calling me on my phone and I have on my email and the interview began.

When answered the phone call he said I thought what the heck out just give you a call and of course she did. I introduced myself and explained a little something about MUFON and what we do how we do it because he was a little apprehensive per say so that kind of cleared his mind somewhat.

I asked them the about the object and what it was doing and in which direction. He said that that it was a red colored object and it I mean really read like a deep red and it was moving very slowly to the east. I asked at that time what was it doing and he said that it was moving slowly as I said and that it dropped like a smaller object of the same color. I asked what you mean and dropped another object and he said that it was the same color as the big one but moving slowly down word then suddenly sped up going straight down. I asked him if there was any time noise of this thing in a crashing or any kind of sound it might've made as it was going down and he said no sound at all. He also stated that the larger object did not make a sound and right after it dropped the little one it moved a little bit to the east and stopped again and then started moving again and disappeared. I asked about the size of it and about how far away from him it was and he said that it was about maybe about a mile and I half and could be over the camel's back reserve. When he said camel's back reserve I went ahead and looked it up on Google earth and saw that it was about a mile and a half from him.

Then I asked him about the angle of degrees and he said about 40 to 45 degrees and an altitude of about 2000 feet. He also stated the weather was very clear in brisk like cold he said. He also stated that he called his brother law and asked him if he had seen something in that area of camel's back reserve and he said yes she did he sought as well. I said so that means there are three of you include in your brother law that is that has seen this in same time and he stated yes. I asked him where his brother lived and he said that he lived about 4 miles from them and to the southeast. So I figured that his brother mall living southeast of him from a reference point and looking to the north northwest a little that would put him looking over porch camel's back reserve. The interview was basically at an end but I asked him a question of why he did not answer the questions I emailed him but called me instead. He stated that all what the heck am of the call you anyway and come to find out that he works at the mountain Home Air force base teaching at a school there. And he said that is why I wasn't going to give phone number out or anything like this that because of possibility of ridicule or somebody's thing something and I might get in trouble or not I don't know. But he said what the heck I called you anyway said I could have somebody talk to. He then started talking about other sightings that 93 and 94 that was around the area that and at this time the interview ended.

#### Detailed Description of the UFO Event:

My family and I were going out to the car at about 9:15 - 9:30 Christmas eve. I looked up to the Northeast over my house and saw a VERY bright red globe hovering in the distance. expecting it to be a helicopter I realized it was not flashing and was not quite the right shade of red. I pointed this out to my family and they watched it with me. it did not move but seemed to be hovering up above everything emitting no sounds (this is what was disturbing) after watching it we got in the car to go along in that direction keeping an eye on it when a secondary object dropped from the main one slowly going down leaving a small trail. as it headed down it sped up in its decent out of sight. after that the main object literally just disappeared. **Witness Interview:** | I called the witness and she answered. I began by introducing myself and the interview began. I asked her if she could describe the object that she had seen and what it was doing. She stated that it was a bright red ball like you red red instead of just something that was brighter and it was a red red and was moving very very slow to the east and then it dropped its that Mahler object of the same color. I asked her what did she mean by dropping something that was smaller and same color and she stated that all of a sudden a smaller craft or orb if you will came out of it and was moving down slowly then sped up out of sight. I asked what do you mean by sped up out of sight was it moving across the sky or straight down and she said straight down. I asked her if there were any sounds at all of a crash and she said no there was no sound of anything. I asked her to go ahead and continue with what she saw and what it did.

She stated that she had never see the like it before and it was amazing. And this is in her own words I picked out my cell phone to take a picture and it did not come out too well and that's why I did not included into my report. She said that she considered too made it for me to take a look but it's not a good and she was right to as the photo was to distorted. I then asked her about the size of the craft or the object if you will and she said it was about 3/8 inch and the one that dropped was a little bit smaller. I asked her about the weather and she said it was clear and then I asked her about the distance from her and it possible the altitude and she stated the distance was about 2 miles to the north and maybe 2000 feet up in altitude at a 50° angle that. She said she was looking over the trees which were about 80 to 90 feet away from her from her balcony and it finally disappeared after about 5 minutes.
