Keyhoe's book was the first non-fiction book on the subject, published in May 1950, several months before Scully's in Sept 1950.

Much of the "info" in Scully's book is factual but the Aztec hoax is a non-event despite desperate efforts by UFOlogists in the 1980's and ever since, to resurrect it through brute force bootstrap methods, out of competitive jealousy-driven rivalry to Roswell. **Not one single 1948 publication or document** refers to any event at Aztec in March 1948. Whereas Roswell was an actual July 1947 event, an indisputable fact, with **worldwide publicity in July 1947**, regardless what conclusion one makes of what actually happened.

Even before the jealousy-driven propping up of Aztec, its resurrection began as a traceable AFOSI disinformation operation in 1982. Bill Moore briefed AFOSI agent Doty on the **Aztec case as a hoax** in late 1982, based on his investigations of Scully, Newton and GeBauer as a possible 2nd Roswell incident. A few months later Moore was shocked to discover that his research showing Aztec was a hoax had been turned into Aztec-as-genuine in the forged Aquarius Executive Briefing for Carter "1977" presented by AFOSI agent Doty to Linda Howe on April 9, 1983.

As Moore put it:

"the information which changed hands that day [in 1983] was directly descended from the discussion Doty and I had had on that very topic only a few months earlier! I can also tell you that it was a very effective deception.... To the best of my knowledge, it was all disinformation; and I was the one who had unwittingly supplied the fuel to those who were spreading the fire."

If one investigates what Scully wrote or published **before** his book (and which can still be traced into his book) it is clear that Aztec is a false disinformation story invented to discredit Roswell by changing details of location and date as misdirection away from Roswell and onto a non-event that would prove to be a dead-end. In Dec 1949, the Scully-Newton-GeBauer-Koehler story was that a saucer had been recovered from a **ranch** in New Mexico **near a proving ground** (obviously White Sands Proving Ground) in the Summer of 1947 and **taken by a General to TEXAS**. Sound familiar?

(The Brazel Debris Field is closer to White Sands Proving Ground at about 47 miles versus about 58 miles to Roswell downtown.)

Within days, in early Jan 1950, the story was transformed into Aztec, location changed by about 250 miles, the date moved into 1948 or 1949, the "ranch" detail deleted and no more mention of a proving ground.

Yes, that's right, the original Aztec date in Scully's unpublished draft book manuscript was "Spring of 1949" not March 1948.
